DISTRICT DESCRIPTION

Freeman Public Schools is a rural PreK-12 district created by the consolidation of Adams and Filley Public Schools in 1998. The school attendance center, located in Adams, is approximately 30 miles southeast of Lincoln. Freeman Public Schools consists of a preschool program for 4-year-olds, a Kindergarten-6th Grade Elementary, a 7th and 8th Grade Junior High, and a 9th-12th Grade High School. Freeman Public Schools employs approximately 75 certificated and classified staff members to serve the children and families within the district. Freeman's PK-12 student population is approximately 480 students.

The district provides 1-to-1 technology for all students in 7th through 12th Grade, with Chromebooks traveling between school and home daily. In Kindergarten through 6th grade, 1-to-1 technology is provided with devices housed at school.

Freeman's PK-6 elementary has two half-day preschool sessions and two classroom sections per grade. Freeman Elementary has implemented Positive Behavioral Interventions and Supports (PBIS). This program aids students in understanding the expectations for sharing space and learning and how their actions impact their personal outcomes.

Each core area in the 7-12 school has at least two teachers due to Freeman's consistently growing enrollment. Freeman implements a junior high school model for 7th and 8th grades and a high school model for 9th - 12th grades. New 7th and 8th grade Explore opportunities were added in 2020-2021 in the area of Career and Technical Education. Seventh-grade students take an introduction to Woods and 8th graders take an introduction to small engines. In 2021-22, high school pathways in several areas were introduced with each beginning with a foundational course and ending with the potential for a work-based learning experience. Additionally, new high school courses were added in the areas of Construction and Trades and Student Leadership.

As the district student population grows, so do the facilities. In May 2012, a bond issue was passed to address facility needs both inside and outside. Construction of a new competition gym, locker rooms, offices, a classroom, commons area, and a satellite kitchen/concessions area was completed in November 2013. Outside of the bond issue, a new football/track stadium was completed in the fall of 2014. In 2021-22, Freeman Public Schools staff and school board began exploring options to expand facilities for Career and Technical Education opportunities. As a result, a facility study was completed during the 2022-23 school year outlining potential growth areas.

Freeman continues to be an outstanding school with many opportunities for students. In addition to being a high academically achieving school, students get a balanced education with the opportunities to be involved in numerous activities and athletics. Community and patron support continues to be one of Freeman's greatest strengths.

AQUESTT CLASSIFICATION

The Nebraska Department of Education uses the Accountability for a Quality Education System, Today and Tomorrow (AQuESTT) system to annually recognize and classify schools and districts as Excellent, Great, Good, and Needs Support for Improvement based on identified statutory criteria, and other evidence of activities of schools and districts to improve student achievement. AQuESTT serves as a framework for approval, accreditation, and accountability. The tenets of AQuESTT fall within three broad domains: Leadership; Success, Access, and Support; and Teaching, Learning, and Serving.

Freeman Pre-Kindergarten Enrollment

Freeman Public Schools provides a morning and afternoon 3.25-hour preschool program for 4-year-olds, where all children learn and build confidence through play. Since the 2016-17 school year, Freeman's preschool program transitioned away from serving both three- and four-year-olds and now only serves four-year-olds. Our half-day program provides opportunities to socialize and develop many pre-kindergarten skills such as positive social-emotional skills, letter recognition, beginning number sense, and development of fine motor skills for handwriting.

Net Option Enrollment

Net option is calculated on October 1st of each year and compares the difference between the number of students enrolled at Freeman but not residing in our district and the number of resident students enrolled in another school district. For example, if Freeman has ten students enrolled who do not live in the district and two resident students who attend another school, the net option calculation is 10 - 2 = 8. Net option funding is calculated based on this number and part of the state aid given to public school districts. Students in Preschool are not included in net option totals.

2022-23 Student Data Comparison

Freeman Public Schools has shown growth and stability over the past ten years. K-12 enrollment has increased by 71 students over that span, an increase of 18.7%. Over this time, Freeman students have maintained an attendance rate near 96% and a graduation rate at or near 100%. Free and reduced lunch, special education, dropout, and mobility rates all fall below the state average.

FREEMAN STAFF INFORMATION

The Freeman Public Schools faculty and staff are dedicated to providing the highest quality education to our students. Certificated staff take part in multiple staff development opportunities throughout the year. This included seven days dedicated to professional development during the 2022-23 school year. Freeman currently has nearly 57% of its teachers obtaining an advanced degree. There are currently 29 teachers with ten or more years of experience at Freeman. Of those 21, five teachers have worked at Freeman for twenty or more years. Of those five, we have two faculty members who have been at Freeman for over 30 years. Freeman's average years of teaching experience is 16.13 years. In addition to our certified faculty, Freeman employs approximately 35 classified employees who fulfill a wide range of responsibilities. Classified employees include bus drivers, paraprofessionals, custodial/maintenance staff, nutrition staff, business manager, and office staff.

STUDENT TRANSPORTATION

State Aid and Tax Asking

State aid and Freeman's total tax asking over the past five years can be tracked below. Nearly all of the state aid that Freeman Public Schools receives is net option funding. As a result, state aid amounts are difficult to estimate and can fluctuate by large amounts from year to year. Since 2019-20, Freeman's net option enrollment number has increased by 37 students, resulting in substantial increases in state aid.

2022-23 Bond Fund Report

Freeman Public Schools currently pays on two 20-year bonds resulting from the 2006 and 2012 construction projects. The scheduled payoffs of these bonds will occur in the 2032-33 school year. In 2022-23, two bond payments were made by the district totaling \$574,011. In addition, an inter-fund loan was made for \$200,000 from the Bond Fund to the Special Building Fund to purchase land.

2022-23 Building Fund Report

The Special Building Fund is used to acquire or improve sites and/or to erect, alter, or improve buildings. In 2022-23, Freeman levied 3.3 cents to the Special Building Fund which equated to a tax asking of approximately \$193,000. Several projects were completed in 2022-23. The final portion of a multi-year roof replacement project was finished along with masonry work to the West side of the building, additional lockers, a South gym audio upgrade, and LED lights. In August 2022, Freeman Public Schools hired Clark & Enersen to conduct a facility study which was completed in June 2023. Lastly, two parcels of land were purchased in 2022-23. This land will be used to increase athletic green space and parking.

STUDENT ACHIEVEMENT

NWEA MAP Assessment

The NWEA MAP Assessment is a norm-referenced test that is given during the school year to Kindergarten through 11th graders in the areas of Math and Reading. The MAP assessment is dynamic and adaptive and adjusts the difficulty of the questions to match the student's current level and success. This assessment also gives our faculty immediate access to student progress and allows our teachers to fully understand what skills each of our students excels at and in what areas further assistance is needed. The MAP Assessment given in the Winter also gives students, teachers, and parents a projection on how the Spring NSCAS assessment should go based on their score.

Nebraska Student-Centered Assessment System (NSCAS)

Beginning in 2017-18, the state of Nebraska implemented the Nebraska Student-Centered Assessment System (NSCAS). Students in Grades 3-8 complete assessments in English Language Arts and Mathematics. The Science assessment is given in Grades 5 and 8. Freeman's 2022-23 NSCAS assessments were given in the spring and English Language Arts and Mathematics results were returned in November 2023.
